Customers who subscribe to an eligible product for 12 months or more between November 7, 2017 and January 12, 2018 (dates inclusive) can add a further subscription of the same or lesser value product at a promotional discount of up to 25% off* the SRP. The promotional discount applies to new purchases. Please refer to question 5 for a list of eligible products.

 For example: A customer can purchase a new annual subscription of any of the eligible products within Autodesk® AutoCAD® Family products during the promotional period are entitled to receive a discount of up to 25% off* the SRP of a second annual subscription of same or lower value product with the Autodesk® AutoCAD® Family products.
