Official Rules

Important: Please read these official rules ("Official Rules") before entering this Sweepstakes ("Promotion"). By participating in this Promotion, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

NO PURCHASE IS NECESSARY TO ENTER THIS PROMOTION.

Promotion void where prohibited. Subject to applicable federal, state, and local laws.

- 1. Sponsor: Autodesk, Inc. ("Sponsor" or "Autodesk"), at The Landmark @ One Market Street, Suite 400, San Francisco, California 94105.
- 2. Eligibility: The Promotion is open only to legal residents of the 50 United States or District of Columbia who are at least 18 years old (or the age of majority in their jurisdiction of residence, whichever is older). <u>Limit</u>: ONE ENTRY PER PERSON REGARDLESS OF METHOD OF ENTRY. Any attempt to obtain additional Entries, including through multiple or duplicate accounts, may result in disqualification

5. Identity of Entrant: An Entry must be submitted by the individual entrant. Bulk or automated Entries will be disqualified (including Entries made using any script, macro, bot, or promotional service). Multiple participants are not permitted to share the same e-mail for an Entry. Any attempt to obtain additional Entries through fraud or other illegitimate means will result in disqualification, at Sponsor's discretion.

If there is a dispute about the identity of the entrant, the Entry will be declared made by the authorized account holder of the email address associated with the Entry.
