

Additional Terms for Specific Offerings

Certain Token Flex Offerings are subject to additional terms as set forth below (“Additional Terms”). To the extent any such Offering is made available to You via Your Enterprise Business Agreement (“Agreement”), You agree to the Additional Terms for that specific Offering. Capitalized terms not otherwise defined herein will have the meaning set forth in Your Agreement. For any material updates to the Additional Terms, impacted Token Flex customers will be notified via email and such Additional Terms will be updated accordingly and apply to Your Agreement.

(B) You and Autodesk determined Your anticipated use of the Autodesk Platform Services APIs and features to estimate the number of tokens You will consume annually for Autodesk Platform Services Enterprise (“Annual Minimum”). The Annual Minimum is the minimum number of tokens to be deducted for Autodesk Platform Services each year of Your Token Flex Term.

Yearly Estimate. Your actual use of Autodesk Platform Services APIs and related features will be tracked by Autodesk using the applicable usage model consumption table available <https://aps.autodesk.com/pricing> or any successor site provided by Autodesk so that the actual token consumption of Year 1 (if above the Annual Minimum) will set Your Year 2 Estimate and the actual token consumption of Year 2 (if above the Annual Minimum) will set Your Year 3 Estimate. Once set, Your Annual Minimum will be consumed for that year (i.e. You will not be charged additional tokens in any given year for surpassing that year’s estimate nor will You receive a token credit for falling below that year’s estimate). Year 2 Estimate. If actual token costs in Year 1 exceed the Annual Minimum, then the Year 2 Estimate will be the actual token costs of Year 1. If actual token costs in Year 1 fall below the Annual Minimum, the Year 2 Estimate will be the Annual Minimum.

Year 3 Estimate. If actual token costs in Year 2 exceed the Year 2 Estimate, then the Year 3 Estimate will be the actual token costs of Year 2. If the actual token costs in Year 2 fall below the Year 2 Estimate, the Year 3 Estimate will be the greater of, the actual token costs in Year 2 or the Annual Minimum.

Example 1, if Your Year 1 Estimate is 120,000 tokens and the actual token costs for Year 1 total 144,000, You will not be charged for the additional 24,000 tokens. Instead, Your Year 2 Estimate will be set at 144,000 tokens and Your Monthly Token Consumption Rate for Year 2 will be 12,000 (144,000/12).

Example 2: Your Year 2 Estimate is 144,000. At the end of Year 2, Autodesk determines that the actual costs of Your usage total 156,000 tokens. Your Year 3 Estimate will be 156,000 and Your Monthly Token Consumption Rate for Year 3 will be 13,000 (156,000/12).

Example 3: Your Year 2 Estimate is 144,000. At the end of Year 2, Autodesk determines that the actual costs of Your usage total 132,000 tokens. Your Year 3

Estimate will be 132,000, (the greater of the actual token costs in Year 2 or the Annual Minimum).

Example 4: Your Year 2 Estimate is 144,000. At the end of Year 2, Autodesk determines that the actual costs of Your usage total 90,000 tokens. Your Year 3 Estimate will be 120,000, the Annual Minimum.

To determine Your applicable Token consumption, Autodesk will apply the Token Consumption Rate described in Attachment 1 of Your Agreement at the end of each calendar month. Token consumption is based on the number of Tagged Assets and the number of Streams You are using in Autodesk Tandem at the end of each calendar month, rounded up to the next highest increment. The Time Series History for Streams is three (3) years.
