The purpose of the **Voluntary Product Accessibility Template**, or **VPAT™**, is to assist Federal contracting officials and other buyers in making preliminary assessments regarding the availability of commercial “Electronic and Information Technology” products and services with features that support accessibility. Autodesk provides this information to help our customers understand the accessibility features of this Autodesk product in the context of the Section 508 standards. This was done with the intent to enable agencies to be compliant with the Section 508 regulations. This document is not intended to be a certification of compliance.

The first table of the Template provides a summary view of the Section 508 Standards. The subsequent tables provide more detailed views of each subsection. There are three columns in each table. Column one of the Summary Table describes the subsections of subparts B and C of the Standards. The second column describes the supporting features of the product or refers you to the corresponding detailed table, e.g., “equivalent facilitation.” The third column contains any additional remarks and explanations regarding the product. In the subsequent tables, the first column contains the lettered paragraphs of the subsections. The second column describes the supporting features of the product with regard to that paragraph. The third column contains any additional remarks and explanations regarding the product.

Also, a command line enables the user to type in commands directly and specifies other input. Supports key tips for ribbon tabs and most widgets in ribbon. When panels are minimized, key tips don't work. The Panel minimize function does not have a keyboard access method. Provides inconsistent information about user interface elements via the Microsoft Accessibility Applications. For example ribbon text and Tooltips are not available to Microsoft Narrator. Tooltip equivalents of ribbon buttons text are provided, but audio versions are not supported. Toolbar and ribbon button images have textual equivalents</p>

<p>(b) Applications shall not disrupt or disable activated features of other products that are identified as accessibility features, where those features are developed and documented according to industry standards. Applications also shall not disrupt or disable activated features of any operating system that are identified as accessibility features where the application programming interface for those accessibility features has been documented by the manufacturer of the operating system and is available to the product developer.</p>	<p>Supports</p>	<p>Testing has indicated that the AutoCAD Plant 3D software program does not disrupt the accessibility features of other products on the user's system.</p>
<p>(c) A well-defined on-screen indication of the current focus shall be provided that moves among interactive interface elements as the input focus changes. <p>(g) Applications shall not override user selected contrast and color selections and other individual display attributes.</p>	<p>Supports</p>	<p>Application does not override contrast and color selections. Testing* shows that the application performs well under high contrast settings. The user can also change color settings.</p>

<p>(h) When animation is displayed, the information shall be displayable in at least one non-animated presentation mode at the option of the user.</p>	<p>Supports</p>	<p>Animated displays are included only within the product's help system. The same information is documented with text and images.</p>
<p>(i) Color coding shall not be used as the only means of conveying information, indicating an action, prompting a response, or distinguishing a visual element.</p>	<p>Supports</p>	<p>Color-coding is not used as the only means of conveying information. The user can enter a color index or in certain cases an RGB value. Users can also use predefined named colors as described by PANTONE®, RAL, and DIC® color systems.</p>
<p>(j) When a product permits a user to adjust color and contrast settings, a variety of color selections capable of producing a range of contrast levels shall be provided.</p>	<p>Supports</p>	<p>The product provides a variety of color selections that produce a range of contrast levels.</p>
