



## **BILLING INSTRUCTIONS**

Dear Supplier,

Autodesk uses the Ariba Network to transact with our suppliers; there are no fees for you to join or transact with Autodesk over the Ariba Network.

In order to submit invoices to Autodesk, your company must register on the Ariba Network. There are 2 ways to register:

1. By accepting a "Trading Relationship Request" from Ariba via email
2. From your Purchase Order, click the "Process Order" button to create a new Ariba Network account or to log into your existing Ariba Network Account

There is no change to the current invoice submission process if the Autodesk entity you are billing resides in the following countries:

*Argentina, Brazil, China, Colombia, Czech Republic, India, Israel, Italy, South Korea (non-digital tax invoice or not 전자세금계산서), Mexico, Poland, Qatar, Russia, Saudi Arabia, Taiwan, Turkey, UAE*

Please ensure that your invoices are compliant to the Autodesk requirements and the local taxation and statutory regulations.

Your invoices must always indicate a valid Autodesk Purchase Order (PO) number.

***PO number starting with 45XXXXXXXX (after 1 Sept 2019) or 5XXXXXX (prior to 1 Sept 2019).***

Do not accept an order if you did not receive an official Autodesk Purchase Order or if the amount does not match with your offer/price.

## **INVOICE SUBMISSION**

### **1. Ariba Network e-Invoicing**

- Supplier to submit invoices against the Autodesk PO via [the Ariba Network](#).

### **2. Original Hardcopy Invoices**

- Supplier to submit the invoices to the respective Autodesk local office or billing address stated on the Purchase Order if the Autodesk entity you are billing resides in the following countries:

*Argentina, Brazil, China, Colombia, Czech Republic, India, Israel, Italy, South Korea (non-digital tax invoice or not 전자세금계산서), Mexico, Poland, Qatar, Russia, Saudi Arabia, Taiwan, Turkey, UAE*

### **3. Soft-copy Invoices**

- Strictly 1 invoice in 1 PDF (letter size format) and no handwritten PO
- Supplier to submit the invoices to the respective mailboxes listed on page 5

## **INVOICE REQUIREMENTS**

Your invoices must contain the following information:

### **Billed From/Shipped From:**

- Supplier's company name and complete address
- Supplier's VAT/GST/Tax ID/ABN/Company ID/PAN number

### **Billed To/Shipped To:**

- Autodesk's complete name and address you are doing business with
- Autodesk's VAT/GST/Tax ID numbers you are doing business with
- Valid Autodesk Purchase Order number(s): 45XXXXXXXX or 5XXXXXX

### **Transaction Details:**

- Invoice Number
- Invoice Date
- Invoice Total Amount
- VAT or Tax Amount and Rate presented separately
- Invoice Currency (must be the same as the PO Currency)
- Description of transaction (quantity, price, goods delivered, service provided)

### **Additional Requirements:**

- Place or country where the products are shipped or services are performed
- For invoices billed to Autodesk entity residing in [EU countries](#):  
The statement from the relevant VAT Directives if Zero Percent or No VAT is charged (*e.g. Importation, Intra-community Acquisition, Reverse Charge, Multi-jurisdiction, or Triangulation transactions*).
- For original hardcopy invoices, please affix company stamp or signature.
- Other requirements as per local taxation and statutory regulations.
