



The Building Safety Bill and Golden Thread Requirements

The Building Safety Bill (Draft)

- When is it law? Royal Ascent is expected summer 2022, however there will follow a number of changes to incorporate additional elements such as extension of limitation for defective premises and Changes to the Regulatory Reform Order (Fire Safety)
- Does it cover just high rise buildings? The Bill and new Regulator cover all buildings, not just "high rise residential". It addresses how we design, build and renovate all our buildings in future.
- Is it retrospective? The draft Building Safety Bill will extend the limitation period for claims under the DPA 1972 from 6 years from practical completion to 15 years. This extension will apply retrospectively as well as prospectively, i.e. to claims that are currently already time-barred.
- Is it just new build? it will be mandatory for an accountable person to register existing occupied high-rise residential buildings with the newly established Building Safety Regulator within a defined period
- Is the Golden Thread of Building information required for all buildings? The government set out that the golden thread will apply to all buildings within scope of the new more stringent building safety regime, being introduced through the Building Safety Bill.

The Building Safety Bill (Draft) Duty Holders

What will the Building Safety Bill Regulations (draft) do?

These draft regulations set out the framework of duties for those persons and organisations ("dutyholders") who commission, design and undertake building work to which building regulations apply.

The bill makes clear who the dutyholders are and impose duties on them. These dutyholders will be: •Client

- •Principal Designer
- •Designers
- •Principal Contractor
- •Contractors

Dutyholders will need to work together to plan, manage and monitor the design work and the building work, ensure they cooperate and communicate with each other, coordinate their work and have systems in place to ensure that building work, including design work, complies with all relevant building regulations. The regulations will also set out the competence requirements (i.e. the skills, knowledge, experience and behaviours) that those dutyholders will need to have to undertake work and ensure that those they appoint are also competent to carry out that work.

Digital adoption throughout the process will enable, evidence, robust process, drive behaviours, enhance management, create an archive of decision making

The Golden Thread in a local authority context

What is the Golden Thread? The Golden Thread is both:

- > the information about a building that allows someone to understand a building and keep it safe
- by the information management to ensure the information is accurate, easily understandable, can be accessed by those who need it and is up to date

Why the Golden Thread? Grenfell Tower showed that asset owners did not know enough about their buildings and the risk they presented so the risk could NOT be managed


- Having data about our assets supports effective decision making
- > Having data on our assets means our statutory and moral duties can be demonstrably discharged

The Golden Thread – What's In It?


- The Golden Thread content and standard will be part of the second legislation and is therefore still in development (but will include information like: Layouts, locations, Fire point access, Mechanical systems and other key data, Structural make up, cladding, exit and protected routes etc.)
- It will be the duty of the people responsible for a building to put in place and maintain a golden thread of information.
- The golden thread needs to be created before building work starts and the golden thread must be kept updated throughout the design and construction process (for example where, through the change control process, the plans for the building work are changed). When the building work is completed the golden thread must be handed over to the Accountable Person, who is responsible for the occupied building.
- Implementation of the golden thread will require individuals and organisations responsible for a building to have good information management systems and a clear understanding of how information management supports building safety.
- Government will set out the specific requirements for the golden thread in secondary legislation
